A lot of ASHHRA members are NOT HHRAM members – could be a good way to grow membership – Laurie and Lisa to se how to contact those individuals.
Business Partners:  Create BP relationship template  Engage members at large to reach out.	Chad Engstrom / Dave Mandel	Dave and Chad have created a template to send to vendors. Then HHRAM BP's could fill it out, this may give some traction. BP's identify relationships with vendors, and reach out to get them on-board with HHRAM.
